Dear Friends,

The Foundation had an exciting year introducing new initiatives and programming. Key accomplishments in 2012 included the following:

- Provided scholarship opportunities to 135 individuals.
- Creation of two additional Named Endowed Scholarships.
- Increased visibility and relationships with major universities providing scholarships to the next generation of real estate professionals.
- Expanded presence and involvement with the American Real Estate Society (ARES), delivering valuable research to CCIM members and exposing the Institute to ARES members.
- Continued development of a real estate donation program to further educate CCIM members, and enable the Foundation to work as a service partner with other non-profit organizations qualified to receive gifts of real estate.

The Foundation has been challenged in recent years by a reduction in donations due to the lingering impact of the recession upon CCIM members, most notably the \$25.00 voluntary contributions received through the Institute's annual dues billing. To protect our financial assets, we were able to reduce administrative expenditures in 2012 without sacrificing results. Going forward, we will need to develop other revenues to expand our activities.
