

The CCIM Institute Foundation started many exciting new programs during this time which includes the Veterans and Diversity Scholarship Programs. Since 1976, he has developed more than 200 different commercial properties in 23 states. Hawkins was a senior instructor in The CCIM Institute. For 20 years he helped develop and teach financial and market feasibility as well as shopping center development classes. He has taught seminars in cities from Miami to Anchorage.

KANSAS CCIM CHAPTER**DARRELL LEASON SCHOLARSHIP – 2020**

Darrell Leason began his real estate career in 1958 working for Colby Sandlian. Leason worked for Sandlian Realty for twelve years, before striking out on his own in 1970 forming Brokers Investment Corporation with Jack R. Hunt and James R. Burns. At one point, Brokers Investment Corporation was the largest commercial real estate firm in Wichita. In 2015, Leason received the Wichita Business Journal's Commercial Transaction of the Year award as well as the Kansas CCIM/Wichita State University Lifetime Achievement Award for Commercial Real Estate. He was not motivated by awards but always sought to create "win/win" transactions. Leason passed away in 2016 after 57 years as a commercial and investment real estate broker, exchanger, real estate problem solver, and developer. He was an active member of the CCIM Kansas City Chapter, the National Council of Exchangers, and the Society of Exchange Counselors.

In 1975 Humberto Lopez co-founded HSL Properties, Inc., a real estate company with diversified assets of approximately \$2.5 billion located in Tucson, AZ. He has had direct responsibility for the acquisition, capitalization, financing, renovation, and marketing of more than 30,000 apartment units, more than 2,000 hotel rooms, shopping centers, office buildings, industrial buildings, and thousands of acres of land. In 2004 he founded The H.S. 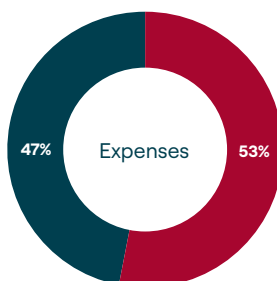
