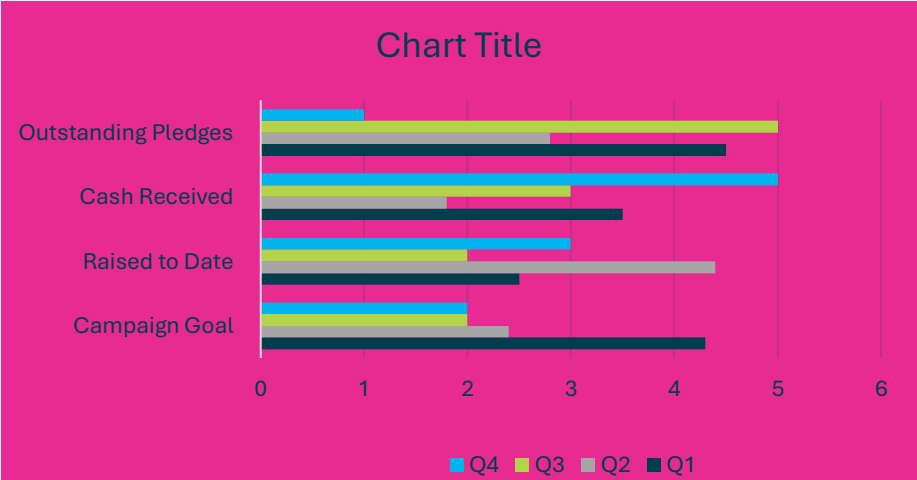

Scholarship Highlights

Four new scholarships were created this quarter:

- Through **The Tim and Barbara Blair Scholarship Matching Fund**, chapters can leverage a dollar-for-dollar matching gift up to \$18,500 to create new, \$37,000 scholarship funds that will support future CCIM candidates for years to come.
